AGREEMENT OF RELEASE & INDEMNITY

No person will be allowed to enter as a competitor in a TTPBA organized racing event unless he has given an indemnity & release in the terms herein expressed. By signing this form the competitor (herein after referred to as "the Competitor") will be deemed to have read the same in full, to be fully familiar with its contents and to have agreed thereto.

By this document, I, the Competitor, acknowledge that I undertake to enter into any event organized by the Organizing Committee of the Trinidad & Tobago Power Boat Association entirely at my own risk and that neither the Organizing Committee, nor any officer or agent or employee of the Organizing Committee, nor any event Sponsor nor, nor any other Sponsor, nor the Trinidad & Tobago Power Boat Association, nor any lender or hirer of any vessel or equipment used in connection with any event, nor any financiers and firms which render essential service gratis, including all officers, agents and employees of the foregoing, nor any volunteer workers assisting in a sanctioned event, nor any owner, tenant occupier or manager of any land used in connection with any sea or land based event held in a TTPBA organized racing event shall be liable directly or indirectly for any loss damage expense or injury (such loss damage expense or injury being hereinafter referred to collectively as "Loss") incurred sustained or suffered by me as a result of my competing or participating in any event whatsoever, and in particular, but entirely without prejudice to the generality of the foregoing I understand acknowledge and confirm that no such liability will arise:-

- (a) In respect of any damage or injury caused to any vessel or person while maneuvering a vessel or launching the same in or out of the water or otherwise launching or removing the same from the water;
- (b) In respect any medical fees or transportation expenses (whether repatriation expenses or otherwise) incurred by the Competitor as a result of injuries sustained by him;
- (c) In respect of any such injury, loss or damage arising out of any sea or land based event;
- (d) In respect of such loss sustained by the Competitor whilst using (whether before, during or after an event) a vessel or equipment supplied by or on behalf of the Organizing Committee.

And in order the better to give effect of the foregoing the Competitor hereby agrees to indemnify, keep indemnified, and save harmless, the Organizing Committee, any officer or agent or employee of the Organizing Committee, any event Sponsor nor, nor any other Sponsor, the Trinidad & Tobago Power Boat Association, any lender or hirer of any vessel or equipment used in connection with any event, any financiers and firms which render essential service gratis, including all officers, agents and employees of the foregoing, any volunteer workers assisting in a sanctioned event, any owner, tenant occupier or manager of any land used in connection with any sea or land based event against any such loss.

I also hereby acknowledge and agree that I have no right, property or interest in any radio or television broadcast, motion pictures, still photographs, tape or sound reproduction taken, made, transmitted, reproduced, or used for any purpose of any TTPBA sanctioned event, including practice, qualifications, the race, awards ceremonies or other events associated with the racing event, also including, but not limited to pictures and sound of me alone or with other persons, with or without racing equipment, as well as any and all receipts there from, and any transcription thereof.

In consideration of their promotional efforts on behalf of the sport, I hereby assign all commercial communication and broadcast rights to the TTPBA and do declare it as my lawful agent and representative regarding such rights. I AGREE, that TTPBA or its assigns, on a non-exclusive basis, may use my name and pictures, including pictures of my racing equipment and pictures taken at any TTPBA sanctioned event for publicity purposes

I HEREBY AGREE to be bound by all of the rules of the TTPBA and agree that decisions of its officials and/or interpretation of its rules will be governed exclusively by the administrative review and appeal procedure set forth in such rules.

In this document a reference to the masculine gender shall include a reference to the feminine and neuter genders, and vice versa, and a reference to the singular shall include a reference to the plural and vice versa.
